#### 1. Introduction

RC2 is in accounting which tackles the challenges of ESG reporting for listed firms in Hong Kong and Mainland. The objective of RC2 is to identify the role of ESG related to environmental and social aspects of ESG reports in creating ESG intelligence. The research component coordinator conducted a preliminary analysis on the accuracy of 2017-18 ESG reports of HKEx listed firms and 815 mistakes or an average of 4.5 mistakes per firm were identified, indicating a serious problem with the ESG reports. Previous research indicates that there are many errors and misunderstandings in the content of the ESG reports, which are a mandatory requirement for Hong Kong listed firms. To provide references for the listed firms' ESG reporting, this analysis classified the mistakes and misinformation into 5 categories, namely, Misunderstanding of Stakeholder Engagement, Environmental Data Collection, Environmental Data Calculation, Misunderstandings in Social Aspect, and Misalignment between HKEx Guidelines. Therefore, RC2 should bring significant value to the overall ESG intelligence for researchers, regulators and industry professionals who need ESG intelligence reflecting the quality of ESG reports of listed firms.

#### 2. Methodology and Evaluation Design

#### 2.1. APE ESG disclosure valuation approach:

The methodology was developed by Prof. Louis Cheng with support from external experts. The methodology was developed based on HKEx ESG framework to evaluate disclosure rating of ESG reports for Hong Kong listing firms. The methodology was being tested and the sample of the result is listed in part 2 below.

#### 2.2. Testing Sample

The testing sample contains 125 listed firms at HKEx, covering 11 industrial sectors under GICS1. Appendix 1 lists the details of the firm information and APE scores. Overall, in Table 1, the mean of the total sample's APE score is 87.0 and the range is between 62.4 to 100.0. Due to the small sample size and the unequal sample sizes per group, the median of APE score is used to demonstrate the average level of each sector. The highest median is from the Information and Technology sector, reaching 93.4 and the lowest median is 83.0, from the Industrial sector. Communication Service and Materials sectors have the smallest standard deviation of 3.6, indicating their APE scores are of a consistent level. While the Energy sector's standard deviation is the largest among all the sectors, peaking at 13.1, which may be caused by the small group sample size and the industry performance gap. The overall statistics from the testing sample indicate that the APE score is an acceptable measure. The APE score distribution ranges are listed in Table 2 below. There is a distinctive differentiation of APE scores among the sample firms.
